As you're aware from previous correspondence that has been shared with River Run residents, the 2020 Council approved alignment identifies a need to acquire the River Run townhomes to support construction and operation of the future Green Line LRT. The City continues to work with impacted property owners along the approved alignment and is committed to negotiating agreements with any owners who are interested in doing so. The City remains committed to fair and open negotiations with owners of the River Run townhomes to ensure that all owners are fairly compensated as part of any negotiated transaction and encourages any owner who wishes

to participate in this purchase and sale process to contact the City. City Administration currently has no ability to acquire the properties in any manner other than through these negotiated transactions.
